accredits eligible professional organisations of healthcare professions currently not subject to statutory registration with a view to ensuring the governance of the professional bodies, professional competency of healthcare personnel, and providing more information for the public to make informed decisions when choosing healthcare service providers.

Under the principle of "One Profession, One Professional Body, One Register", the Hong Kong Institute of Audiologists (HKIA) has been authorised by the Department of Health as the accredited healthcare professional body responsible for administering the register of audiologists.

The HKIA is permitted to use the Accreditation Mark on its website and Certificates of Registration issued to its members. Members of the HKIA can use the title "Audiologist in Accredited Register" on their name cards for easy identification by the public.

聽力學家普遍持有聽力學的碩士或博士學位,並具 備相關臨床經驗,憑其專業知識,為不同年齡人士,包括 嬰兒、兒童、成年人及長者,提供聽力學服務。

Audiology is the study of the auditory system, including the hearing and balance functions. It covers auditory function, balance and other related systems, as well as the prevention, identification, assessment and rehabilitation of hearing. Audiology services include hearing test, public education on hearing protection, assessment and rehabilitation of balance functions and tinnitus, prescription and fitting of hearing assistive devices, etc.

Audiologists in general have a Master's or Doctoral degree in the field of audiology with relevant clinical training, providing audiology services for persons of all ages including infants, children, adults and elderly with their expertise. 香港聽力學家公會 Hong Kong Institute of Audiologists

成為「認可名冊聽力學家」 Becoming "Audiologist in Accredited Register"

聽力學家名冊會員須持有認可專上學院頒授具臨床訓練 的聽力學碩士或以上學位,課程內容須與訂明的知識體 系相符。

聽力學家名冊會員亦須提供文件以證明:

- 已完成聽力學臨床實習;或
- 已通過聽力學臨床能力考核;或
- 於獲取認可聽力學碩士或以上學位的地區,獲相關海外 監管機構授予聽力學認可執業資格。

Registrant must hold a Master's degree or above in audiology, with clinical training included, awarded by a recognised tertiary institution, with elements consistent with the Body of Knowledge as stated.

Registrant must also provide documentary evidence of:

- having satisfactorily completed supervised clinical practicum in audiology; or
- having passed an examination on clinical competence of audiology practice; or
- having been granted the right of audiology practice by a governing body of audiology service in the jurisdiction, in which a recognised Master's degree or above in audiology was obtained outside Hong Kong.
